Bremen practices solidarity with people suffering from injustice and oppression not only through its citizens, its associations and foundations, in churches and in politics but also demonstrated solidarity by its active support of the anti-apartheid movements in South Africa and Namibia, to which Bremen committed itself already in the late 1970s – before any other state in Germany.

Against this backdrop, the Bremen Senate established the Bremen Solidarity Award in 1987.

As many as nineteen recipients have been distinguished with the Bremen Solidarity Award since 1988, and I am proud to be able to introduce them to you here. I have the utmost respect for their tremendous courage and their commitment in their fight for justice and the observance of human rights.

THE BREMEN SOLIDARITY AWARD

The Senate of the Free Hanseatic City of Bremen founded the international Bremen Solidarity Award based on a resolution of 10th November 1987. The prize is intended as an encouragement to persons and groups that devote special efforts to overcoming injustice in the North-South relationship and the consequences of colonialism and racism, and espouse democracy and human rights.

The Bremen Solidarity Award is awarded biennially. It is endowed with 10,000 euros, of which half is contributed by the Senate and half by the private R+R Reinke Foundation.

Along with the prize money, the recipient is presented with a sculpture by Bremen artist Prof Bernd Altenstein depicting the Town Musicians of Bremen as a symbol of the power of solidary action. Beneath the prominent animal masks, the story of the Bremen Town Musicians begins with a kick. Individuals falling and picking themselves up form a dynamic group.

The first Bremen Solidarity Award was awarded in 1988 to Nelson and Winnie Mandela.

The Senate chooses the recipients of the award with the assistance of an independent advisory committee made up of recognized experts on development policy.

AWARD CEREMONY IN THE UPPER TOWN HALL

Presided over by the mayor of the Free Hanseatic City of Bremen, the award ceremony takes place in the Upper Hall of Bremen’s historic Town Hall. Well-known figures from the areas of politics, academia, civil society or the media are invited to deliver the honorary addresses.

A framework programme organized with the recipient accompanies the festive presentation of the Solidarity Award.

NETWORKING

Public visibility and strong networks are essential to highlight and support the commitment of the recipients of the Bremen Solidarity Award. To this end, the Free Hanseatic City of Bremen organizes a tailored program for each awardee, consisting of expert dialogues and public events with key political and civil society actors in Bremen, Berlin or Brussels. Young activists in particular often lack access to political contacts at the national and European levels.

The Free Hanseatic City of Bremen therefore supports the awardees by using its contacts at national and European levels to help them present their work to the public and in political settings, and to build connections with key figures from the Federal Government, the Bundestag, the European Parliament, the European Commission, and civil society organizations.

Honorary speech: Dr Monika Hauser, medica mondiale

The Bremen Senate honours Meseret Hadush Weldemariam from Tigray, Ethiopia, with the 19th Bremen Solidarity Award, presented on 29 September 2025, in recognition of her outstanding commitment to women and girls in Tigray who were subjected to sexualized violence during the brutal conflict in northern Ethiopia. As the founder of the aid organization Hiwyet (Healing), Ms Meseret advocates for survivors, provides support, documents their suffering, and gives voice to those affected.

The armed conflict in northern Ethiopia escalated into a civil war in November 2020, following years of mounting tensions. It is considered one of the most brutal and deadly confrontations in recent history. Mass rape, sexual enslavement, and mutilation were systematically deployed as weapons of war against women in Tigray, with the intent to shatter communities and annihilate the Tigrayan ethnic group.

A distinctive feature of Meseret Hadush’s work is the survivor-centred approach, which places the dignity and safety of those affected at its core and aims to foster long-term empowerment and reintegration into society. Hiwyet supports survivors by providing safe accommodation, organizing psychological care, and offering training programmes to help women build economic prospects. To counter social stigmatization, Ms Meseret actively involves community leaders

and religious figures in her work and promotes a culture of listening, recognition, and healing.

At great personal risk, Meseret Hadush has played a vital role in documenting the atrocities committed during the war in Tigray. She collaborated with journalists to secure witness testimonies and gather evidence—an important contribution to legal protection and prosecution in current and future conflicts.

The presentation of the Bremen Solidarity Award to Meseret Hadush sends a powerful message against the use of sexualized violence as a weapon of war against women and girls worldwide, and gives a voice to survivors of this largely forgotten conflict and beyond.
